Notice to Exhibitors

Un-entered dogs may not be crated in the building.

- Bitch in Season notes for refund must be presented to the trial secretary no later than 30 minutes prior to the start of the trial.
- The building will be open at 3:45 PM on Friday. The building will be open at 6:45 AM on Saturday and Sunday. Crates may not be left overnight. Exhibitors and handlers will be responsible for clean conditions in and around their crating area
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash or confined to a crate except when being judged.
- Please use the clearly marked potty areas, and not the adjacent properties. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement.

From I95 North and South:

Take Exit 1A to Route 896 South (towards Middletown)

At next light, Turn Left onto Old Baltimore Pike

After crossing the Cooches Bridge, turn right onto the second drive and follow around to the WKC Building. The signs are for Dayette Mills, Horizon Helicopter, and Wilmington Kennel Club.

Coming From South Delaware

From Route 1 North, take the Route 72 Exit and go West.

Cross Route 40, then turn left at the next light, Old Baltimore Pike.

WKC is the first drive on the left.

Head south on DE-72 S toward Dayett Mill Road

Turn left onto Reybold Road .8 miles

Turn left onto Salem Church Road 1.1 miles

Turn right onto S Old Baltimore Pike 2.3 miles

Turn right onto DE-273 E 1.6 miles

Turn left onto DE-37 N 1.2 miles

Turn right onto DE-58 E, destination is on the left .3 miles

Judging Schedule and Assignments

- **Judge will take luncheon breaks at their discretion**
- For your convenience, totals have been carefully tabulated. Neither the club nor the show secretary assumes responsibility for absolute accuracy. Numbers subject to corrections and transfers not yet received.
- Times listed are the earliest possible times that classes can start. If the published judge and ring are available prior to the listed start time and all exhibitors have checked-in and agree, the judge may start a class earlier than the class time listed in the judging program.
- Rally times listed are the earliest possible time that the walk-through, followed by judging for that class, will begin. Transfers for the Excellent and Advanced classes will be placed in jump-height order. Walkthroughs may be combined at the judge's discretion.
- A 10-minute Obedience Novice A walk-through (for handlers without their dogs) will take place prior to the start of the class.
